Mt. Hood National Forest: Draft Decision Notice for Environmental Assessment. The Mt. Hood National Forest, Barlow Ranger District has prepared a draft decision notice and finding of no significant impact (draft DN/FONSI) and a final environmental assessment (EA) for the Rocky Restoration project. These documents are available on the Mt. Hood National Forest website at: <https://www.fs.usda.gov/project/?project=48037>. The Rocky project is located in T3S, R10E, sections 35-36; T3S, R11E, sections 35-36; T3S, R12E, section 31; T4S, R10E, sections 1-3, 10-15; T4S, R11E, sections 1-23, 26-27; and T4S, R12E, section 6, Willamette Meridian; Wasco County, OR. The draft decision is the Proposed Action Alternative, which includes vegetation, fuels, and roads treatments. The Responsible Official is Kameron Sam, Barlow District Ranger. This draft DN/FONSI is subject to objection pursuant to Forest Service regulations at 36 CFR 218. Only individuals or organizations that submitted specific written comments during a designated opportunity for public participation (scoping or the 30-day public comment period) may object (36 CFR 218.5). Notices of objection must meet the requirements of 36 CFR 218.8. Objections must be filed with the Objection Reviewing Officer within 45 days from the date of the publication of this notice of opportunity to object. This publication date is the exclusive means for calculating the time to file an objection. The Objection Reviewing Officer is the Forest Supervisor. An objection should be addressed to the Forest Supervisor at any of the following addresses. For postal delivery, mail to: Forest Supervisor, Objection Reviewing Officer, Mt. Hood National Forest, 16400 Champion Way, Sandy OR 97055; hand-deliveries may also occur at this address. Hand deliveries may occur between 8:00am and 4:30pm (closed 11:30am to 12:30pm daily), Monday through Friday, excluding Federal holidays. Electronic objections must be submitted as part of an actual e-mail message, or as an attachment in Microsoft Word format (.doc), rich text format (.rtf) or portable document format (.pdf) only. Emails submitted to email addresses other than the one listed above, or in formats other than those listed, or containing viruses, will be rejected. Objections may also be faxed to: Forest Supervisor, Attn: Objections, at 503-668-1413. It is the responsibility of the objector to confirm receipt of objections submitted by electronic mail.
