OUTREACH AND EDUCATION PROGRAM: Bark provides education to the public about forest law, policy, and ecology at free events that are held online, approximately 100 hours of volunteer time supported these activities. Our street outreach team make phone calls to inform the public about what is happening in Mt. Hood National Forest. In 2020, Bark reached 11,800 people with our outreach team. Bark's regular email newsletter includes more than 25,000 recipients and covers information about forest ecology, public land policy, upcoming events, and ways for people to engage with the Forest Service.

FOREST WATCH PROGRAM: Bark works with our volunteers and the general public to inform policymaking at the US Forest Service. In 2020 we worked to engage the public on issues of wildfire ecology and management and destructive, industrial forest practices such as roadbuilding and commercial logging. Staff and volunteers gather site-specific information by groundtruthing and use the collected data to provide input on proposed Forest Service projects through the National Environmental Policy Act. Bark volunteers contributed approximately 584 hours surveying proposed timber sales and monitoring the impacts of roads and logging in Mt. Hood National Forest. Areas of work in 2020 also included beaver habitat surveys and water depth data collection used to perform wetland mapping for two watersheds of the Clackamas District. A portion of this work was funded with \$20,468 through a contract with the U.S. Forest Service.

RESTORE MT. HOOD PROGRAM: In 2020, Bark proactively advocated for updates to the Mt. Hood Forest Management Plan through online workshops on forest management and climate change. Staff and volunteers managed a website, monthly meetings, community presentations, and actions directed at Forest Service leadership. Volunteers spent approximately 200 hours supporting this program.

Hood National Forest. Bark's Outreach and Education programs also took place remotely; our street outreach team worked from home for nearly 9 months, calling our supporters to provide updates on our work; and our free educational events that are usually held in our office, all became virtual events.
